

## SUMMARY—MEETING WITH THE MINISTER, THURSDAY, JUNE 25, 2020

Acting SLTA President Steven Allen started the meeting by emphasizing the importance of libraries to citizens of Saskatchewan. Both Steven and Minister Wyant agreed that the closure of libraries during the pandemic has posed a significant challenge for many people. Minister Wyant appreciates the effect on the people who rely on libraries, especially as a social hub and for wi-fi access.

Minister Wyant asked if libraries would be opening as per the Province's reopening guidelines. Steven explained that in his region (Wheatland) reopening on Monday, June 29 would be a little too soon. Librarians in the region are being asked to submit safety plans. As well, it will take some time to have the proper cleaning supplies and protective equipment in place. Minister Wyant stated that the government will be looking closely at the protocols put in place by public libraries to help with the reopening of school libraries in the fall.

Steven pointed out the struggles for libraries have been exasperated by the pandemic closures. Systems are concerned about falling behind in technology. The Minister acknowledged that technology is a struggle across the board. He asked what is needed to bring library systems up to date. There are issues with bandwidth, speed and the growing number of people accessing wi-fi. Minister Wyant said that the government would need to know what the needs are to assess from a financial standpoint. Currently, the government is renegotiating CNET with SaskTel. Bandwidth is part of the negotiations, which would increase for school systems and libraries over a five-year term. The Minister pointed out that this is a key part of ensuring the government's plan to grow the economy.

Rising costs of books and materials is a concern for library systems. Steven gave the example of the price rise of electronic books during the pandemic coupled with the fact that electronic book usage has been greater since the pandemic. Minister Wyant asked his staff to meet to discuss this. He also stated the need for people to understand the role of libraries in the community.

Steven reiterated the need for reliable and sufficient baseline funding for libraries. Minister Wyant said that he has been thinking of how the government can be more innovative in providing a sustained and predictable level of funding for libraries.

SILS costs between one and two million dollars to operate in a year. The point was made that if the Province were to consider assuming that cost, this would create more operating funds for libraries. Both Minister Wyant and Steven agreed SILS is a significant and innovated use of libraries. Minister Wyant asked his staff to provide him with numbers.

Steven requested a discretionary resource to access when there are "vision"/needs. Especially as the difficulty with "vision" is that libraries do not know the direction until the community needs become apparent. The Minister pointed out that more is being expected of libraries.

Steven said that the library engagement was an excellent process. It is important to look at it as a way of building libraries. The sector plan was paused when libraries were closed due to the pandemic. The process is set to begin again.

The Minister ensured that he would continue conversations with his office and leadership at the Ministry of Education. He thanked SLTA for their time. On behalf of SLTA and library trustees, Steven thanked the Minister for his time and consideration.
