1. Call to Order

Building Capacity Grant

In association with the Trustee Development Committee, SLTA is applying for a Capacity Building Grant from SaskCulture in order to host four regional meetings to present the Trustee Development modules in order to train the trainers. Donna Challis (ex-director Lakeland), Dennis Taylor (Lakeland), and Nancy Kennedy (Executive Director) are members of the committee.

After some discussion it was decided that the presentation will be divided into three regional meetings: Lakeland/Wapiti/PNLS (meeting in Prince Albert), Regina/Southeast/Chinook (meeting in Regina), Parkland/Saskatoon/Wheatland (meeting in Saskatoon). Each meeting will take place in a library facility.

Success stories from regions – one or two per region – will be collected. A decision will be made on the best way to show case (video, Facebook, etc.). Eric will shortly be sending a letter of introduction to region contacts. He is interested in starting a monthly e-newsletter. Eric will also be working with Nancy Kennedy (Executive Director) to better "advertise" our Facebook page in order to draw more attention to our website.
