# **Industry Canada Funding for Library CAP Sites 2003-04**

- It is anticipated that public libraries will receive approximately \$1 million dollars in sustainability funding in 2003-04. The program will cover the period April 1, 2003 to March 15, 2004.

#### **CommunityNet for Public Libraries**

#### Current status:

- CNet has been installed in 142 libraries as of December 31, 2003.
   Provincial Library awaiting completed templates from SPL which has decided it will not proceed in the near future.
- Provincial Library working with Sask. Learning to determine possible funding sources to add another 65 libraries to CommunityNet.
- Background: The Information Technology Office & Provincial Library assisted the SLTA in the preparation of a Canada-Saskatchewan Infrastructure Program Application for \$4.4M over 6 years to provide 162 libraries with high speed Internet connections.
- Additional information: Each regional library board has determined how to address the matter of equitable costs, because the SLTA application said libraries would ensure equitable distribution of the savings from CommunityNet.

# **Financial Reporting Update**

- At the request of one of the library systems, the Financial Reporting Committee formed a sub-committee to develop guidelines for local library boards.
- Current status: The guidelines provided to ibrary boards who decide to adopt them as policy. The Financial Reporting Committee is working on a Financial Reporting Manual, to provide standards and guidance for financial reporting and to achieve comparability.
- A draft Financial Reporting Manual was distributed to all library systems in December 2003.

#### **IT Projects**

## 1. Horizon Migration Project

 The primary objective of the Horizon Project is to replace the existing Dynix integrated library system with the Horizon integrated library system. Replacement of the system means implementation in the Provincial Library including the currently hosted Chinook and Pahkisimon Nuye?áh Library Systems. The project is proceeding on schedule and on budget.

# 2. Gateway

- The purchase of the gateway software was the first step toward seamless access. It gives the public the ability to search all public library catalogues in a single search and to receive the results in a single list of unique records with locations and item availability statuses.
- · One library system has the gateway on their website.

# 3. Government Online Project for Interlibrary Loan Software and Remote Patron Authentication Software

 The second stage of seamless access is to implement software which will allow the public to create an interlibrary loan request from their search of library catalogues, including the Gateway and for the Saskatchewan user to be validated for restricted library services such as access to licensed databases.

- A web form will be available to the public to initiate their requests from a number of sites.
- The GOL project is being funded by the Government On-Line Fund, Information Technology Office.
- Implementation of the Resource Sharing Software (RSS) is progressing.

#### **GST Rebates**

- On January 9, 2004, Finance Minister Ralph Goodale announced the federal government is considering 100% rebate of GST paid by MUSH sector (municipalities, universities, schools and hospitals).
- In Nova Scotia public libraries are considered as "municipalities: for the purpose of GST/HST rebates.
- SLTA supports this initiative and will write a letter.

#### **Library Book Rate**

## Why is the Library Book Rate IMPORTANT?

The elimination of the Library Book Rate would make it impossible for public libraries to deliver books by mail and would thereby seriously undermine resource sharing, which is recognized by clause 3(1)© of *The Public Libraries Act 1996* as one of the fundamental components of the public library system in Saskatchewan.

Introduced in 1939, the Library Rate (commonly called the Library Book Rate) assists in extending library services to rural and remote areas. Through an agreement with the Department of Canada Heritage, Canada Post provides a discount to libraries mailing print materials to their users or other libraries. It is estimated that the annual cost of this discount to Canada Post is approximately \$1.3 million. The cost of the loss of this discount for libraries and their users is incalculable.

The Department's current contract with Canada Post expires March 2002 and negotiations are beginning for the continuation of the programme after that date. It is not clear, however, that Canada Post will continue to provide

the discount mailing rate to libraries, therefore it is important for the Canadian Library Association and its members to advocate with the federal government for the continuance of the rate.

In preparation for the negotiations the Department of Canadian Heritage will be undertaking a study of the rate. Libraries will be asked to provide date and information in the completion of that study.2

The Library Book Rate is not just a library issue. If is also an issue for all of those who live in rural or remote communities or who, due to illness or disability, must rely on the mail to deliver important reading and learning materials. The elimination or the lowering of the discount would have serious impact on the ability of libraries to continue to provide their mail delivery programmes or to access the collections of other libraries.

CLA is actively seeking the commitment of Canadian MPs and government officials to ensure that both the Department of Canadian Heritage and Canada Post continue to partner to provide the Library Book Rate.

It is estimated that the annual cost of this discount to Canada Post is approximately \$1.3 to \$2 million. At the beginning of the negotiations for the extension of the LBR, it was unclear whether a deal could be reached.

Understanding the value of the Library Book Rate to Canadians across the country, particularly to those in rural areas, CLA spoke to federal members of Parliament and officials from the Departments of Canadian Heritage, Industry Canada and Canada Post. Through its recently launched Campaign for Canada's Libraries CLA voiced its concern that the Library Book Rate might be cancelled during the current round of negotiations. The response given was clear - it is essential to Canadians and their leaders that library materials can be delivered across the country through Canada Post at a discounted rate.

Thus, in February 2002 the Department's and Canada Post reached a new three-year deal. The three year deal will see the current mailing rate for libraries increase by 6.8% in 2002, 0% in 2003, and 6.3% in 2004, an overall increase of 13.1%.

Department of Canadian Heritage officials have commended CLA for taking a proactive stance on ensuring that the LBR continues. The signing of the deal will not end CLA's commitment to expanding the LBR in future years to non-print materials, to ensure its continuance or to limit future increases in the cost of using the rate. CLA will be working with the Department and Canada Post in order to strengthen the ties between the three groups and to begin discussions for the next round of negotiations which will begin in 2004.

These discussions will be based in part on information that is currently being gathered in a study examining the use of the LBR. This study, which is likely to be completed in March-April 2003, includes a survey component as well as consultations, was commissioned by the Department of Canadian Heritage; it is being conducted by ASM Consultants with Fuse Communications. It is imperative that. librarians across the country provide data and input to this study. For this reason, CLA asks that everyone who has received a copy of the Library Book Rate survey to complete it.
